The Medico Legal Death Investigator's purpose is to investigate all Coroner deaths.

Essential Duties/Responsibilities:

What the job duties or responsibilities are:

The Medico Legal Death Investigator must answer all coroner case calls, go to the death scene, remove body from scene and is responsible for a follow-up investigation, certify the death, must record all information and locate and notify next of kin. The investigator will also be responsible for taking forensic photos. Investigator completes all Coroners' forms, records and collects all evidence and acquires medical records when needed. This position requires employee to work shift work and be able to work overtime when needed. Must have working knowledge of Word and Excel programs. Will be required to complete education to be certified as a Medico Legal Death Investigator.

Physical Requirements: sitting, walking, standing and lifting on average 75 – 100 lbs., physically fit.

QUALIFICATIONS/EDUCATION REQUIREMENTS:

- High school diploma or equivalent
- Basic English, Math and Spelling skills
- Availability to work shift work
- Customer Service and Basic Telephone etiquette
- Must maintain a high degree of professionalism and confidentiality

OTHER DUTIES:

Perform all other duties as required.

PHYSICAL REQUIREMENTS OF THE POSITION:

Must be physically capable of performing duties including lifting up to 100lbs. Position requires full use of arms, hands, and legs and tolerate continuous periods of repetitive motion activity. Be able to lift, bend, walk, and reach overhead.
