Comes now, Judge Pera, before the Board of Commissioners of the County of Lake, asking for approval and endorsement of the Odyssey Case Management System in the Circuit & Superior Courts of Lake County, stating that is a free system being offered by the State and is an electronic case management system to replace CourtView, which has been in use for about 16years, Odyssey is a State Wide program and now is in over half the Counties and accounts for about 62% of the total cases filed in the Indiana Courts, it has been installed in all of the major Counties in Indiana: Porter, Allen, St. Joseph, Marian, the Odyssey Case Management has been installed and became operational about a year ago and Vanderburgh County, so we're the last County, it would be installed and operational in early 2018 and program has been demonstrated to the users in June and August. September 29th the Judges voted a General Judges meeting to adopt it as a case management system, when it is installed e-filing of case types, shortly after the installation within the year, the County Council has unanimously endorsed the Odyssey Case Management system and asking for the same from the Commissioners.

Scheub made a motion, seconded by Repay, to approve the deployment of the Odyssey Case Management System. Motion carried.

Repay made comment, stating, When Justice David wants something done I'm sure Attorneys and Judges does what needs to be done to get the job done, it is a free system, however the current system that we're already running on has an excess revenue of about 350 to 400k, so while its "free", it's going to cost somebody some money, so the Council will have to determine who it's going to cost and how it's going to play out, everyone in this room to be aware of the reduction of revenue involved in this system being implemented. Will it be better for Attorneys that don't have to pay(as much) to subscribe, maybe, will it be better for Reporters, maybe, but there are reasons to have concern so moving forward with this system we should make sure that those people across the hall, the Council, is aware and those that are a benefactors of that funding should be aware that that's not going to happen anymore, that 350k that's being used for supplemental pay, etc. is going to go away or its going to come from maybe Bridges or the Sheriff's Department, Judge Pera, responded, stating, Commissioner, I hear your concerns and it is true we will loose the revenue string being produced by the online docket of e-filing, but the Supreme Court has made it very clear to us and everybody throughout the State, that they want a free-access to public records and they've also made very clear that our online docket, our e-filing, are all pilot projects and that those pilot projects are going to come to an end. By implementing Odyssey in the way that we're doing it, we are saving that revenue stream until such time as the switch is split to turn on Odyssey, it will be only then that we will eliminate our CourtView relationship, so I hear what you're saying (Commissioner Repay), the Judges are not happy about the loss of revenue stream, but we all see the handwriting on the wall, the was free and I'd just point out to you that for the first time in history the Supreme Court got General Fund money from the General Assembly in 2015 to help fund all of this, but it also resulted in an increase of a filing fee of \$14 and I don't think that the General Assembly is going to be real happy with making users on the front end pay for these electronic records and then making them pay all over again through the online docket and e-filing cost, so I hear what you're saying and I appreciate your comments, we struggle with this ourselves and thought that this was the best way to go.

Commissioner Allen, closed the discussion, and the motion, to approve, carried 3-0.

WHEREAS, in addition to paying the initial licensing costs for the Odyssey software, the Division of State Court Administration is responsible for paying the yearly software maintenance and support costs and counties using Odyssey do not incur any yearly costs to use the software;

WHEREAS, Odyssey is being offered to the Lake County, Indiana trial court(s) and Circuit Court Clerk at no cost to the County other than the incidental cost that may be required in order to upgrade computer equipment maintained and used in the local courts' and clerk's offices;

WHEREAS, the Division of State Court Administration agrees to pay for the training of the Lake County, Indiana court, Circuit Court Clerk, and probation staff;

WHEREAS, Odyssey offers our citizens access to non-confidential court case information at no cost over the Internet; and

WHEREAS, implementation of the statewide Odyssey case management system is in the best interest of the county and we support Odyssey implementation for the trial court(s) and the Circuit Court Clerk for Lake County, Indiana.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners and Council of Lake County, Indiana, as the Executive and Legislative bodies that:

1. The Commissioners hereby agree to terminate the existing contract for the operation of Lake County, Indiana's current case management system at at such time as the Odyssey case management system is deployed in the Lake Circuit and Superior Courts.

SUBJECT: Memorandum of Understanding and Request for Participation in the Statewide Case Management System (CMS).

Dear Chief Justice Rush:

1. Based on information we have received from discussions with, presentations by, and other materials provided by the Indiana Supreme Court's Division of State Court Administration and its staff, this Court has determined that participation in the new statewide case management system (CMS) is in the best interests of our Court. This conclusion has been discussed with all of the officials who will be involved in supporting the project.

2. We understand that the CMS is to be implemented cooperatively on a county-bycounty basis between the Indiana Supreme Court, the Court's Division of State Court Administration, county courts, County Clerks, Township Small Claims Courts, City and Town Courts and other elected and appointed city/town/county officials throughout the State.

3. Our Court agrees to the deployment of the Indiana Supreme Court's statewide case management system. We understand and agree that this deployment will require a commitment of time and effort on our part.

4. We understand that the CMS will be a statewide system containing substantial amounts of information (including financial information) on court cases and connected to those who use such information. We have been informed of and recognize the scope and complexity of the project. We have been advised that the Division will at its expense provide the case management software and will operate the CMS on a statewide basis. The Division will also provide project team assistance (including training) during the implementation process. We are aware that our Court, will be called upon, and agree, to provide personnel support and to bear various costs as set out in paragraph 7.

5. We understand that we will need, and we agree, to use the standards and protocols and follow the policies for use of the CMS that the Division identifies for all participants in the State. We further understand that the CMS is based upon Indiana Statutes, Rules of Court and applicable case law. We are informed that the Indiana Supreme Court, through the Division, plan for the system to evolve to provide a high

level of standardization of court procedures statewide. Best court practices will be utilized in standardization. We understand that we will play an important role in reaching that goal and may need to modify or abandon current ways of doing business that do not conform to the statutes, rules, case law and/or best practices. We understand that the Indiana Supreme Court will supervise our court's participation in the statewide case management system and will establish procedures for ensuring compliance with the standards established.

6. We understand that the Indiana Supreme Court through its Division of State Court Administration will be responsible for the following subject to appropriated funding:

- a. The cost of the license and maintenance fees for the software.
- b. Any upgrades and enhancement to the software.
- c. Initial training of court and clerk staff.
- d. Statewide system servers but not local servers for document storage, if required.
- e. Interfaces with specific state agencies and, QUEST, the juvenile case management system.
- f. The conversion of court case and financial data in conformance with established Division standards, if conversion is agreed upon.
- 7. We understand and agree to the current plan requiring our Court to supply and/or
- fund:
- a. The client hardware (personal computers, printers, local server if required and related equipment) to be used in our Court unless the Division is able to secure grant funding to assist with this expense.
- b. The local area network(s) required for use of the statewide case management system.
- c. Any communications circuits needed to connect buildings in our county housing users of the CMS.
- d. Any local interfaces if the Division agrees to additional inbound or outbound interfaces. We further understand that we will not have additional inbound interfaces beyond those provided by the statewide case management system without Division approval.

- The conversion of any data other than that referred to in paragraph 6(f). However, the Division reserves the right to perform all conversion to assure that the proper format for loading the data into the CMS is used. e.
- Any personnel costs attributable to filling in for current staff while it trains and works toward implementation of the CMS. f.
- Qualified local IT staff support following implementation of the CMS. g.

8. We understand we may be called upon from time to time to assist with various aspects of the statewide project such as testing and advising other courts and agree to do so. We will develop a structure to enhance deployment and ongoing use of the statewide case management system.

9. We understand that the data entered into the statewide case management system will be the property of the court and subject to the Supreme Court rules and orders relating to control and access to court information and proper management of the statewide CMS.

Please include our Court in your implementation schedule for the Statewide Case Management System called Odyssey. (Attach additional signature page if needed.)

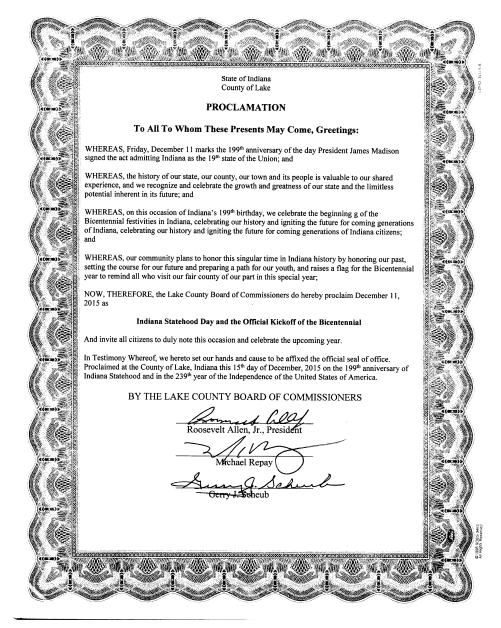

(2) In conformity with IC 5-3-1-4, publish: (A) notice of the date, time, and place for a public sale; and (B) a listing of parcels on which certificates will be offered by parcel number and minimum bid amount; once each week for three (3) consecutive weeks, with the final advertisement being not less than thirty (30) days before the sale date. The expenses of the publication shall be paid out of the county general fund. (3) Sell each certificate of sale covered by the resolution for a price that: (A) is less than the minimum sale price prescribed by section 5 of this chapter; and (B) includes any costs to the county executive directly attributable to the sale of the certificate of sale. (b) Notice of the list of properties prepared under subsection (a) and the date, time, and place for the public sale of the certificates of sale shall be published in accordance with IC 5-3-1. The notice must: (1) include a description of the property by parcel number and common address; (2) specify that the county executive will accept bids for the certificates of sale for the price referred to in subsection (a)(3); (3) specify the minimum bid for each parcel; (4) include a statement that a person redeeming each tract or item of real property after the sale of the certificate must pay: (A) the amount of the minimum bid under section 5 of this chapter for which the tract or item of real property was last offered for sale;

(B) ten percent (10%) of the amount for which the certificate is sold; (C) the attorney's fees and costs of giving notice under IC 6-1.1-25-4.5; (D) the costs of a title search or of examining and updating the abstract of title for the tract or item of real property; (E) all taxes and special assessments on the tract or item of real property paid by the purchaser after the sale of the certificate plus interest at the rate of ten percent (10%) per annum on the amount of taxes and special assessments paid by the purchaser on the redeemed property; and (F) all costs of sale, advertising costs, and other expenses of the county directly attributable to the sale of certificates of sale; and (5) include a statement that, if the certificate is sold for an amount more than the minimum bid under section 5 of this chapter for which the tract or item of real property was last offered for sale and the property is not redeemed, the owner of record of the tract or item of real property who is divested of ownership at the time the tax deed is issued may have a right to the tax sale surplus. Comes now, Jim Nowacki, with public comment, making comment in regards to Item #87 and giving insight on the reason of why tax sales from 40/50 years ago vs over 20.000 properties being sold, presently, and the net-result isn't just that the County looses money but its the devastation that has an effect on the City, stating that one would suggest that people simply walk away from the property because the taxes are too high, referring back to the 18th and 19th Century, mentioning that the lots/property wouldn't sell for as much now, and continuing on stating, "where have you seen such devastation", stating part of the problem is that the City has a mass of 10k properties of their own inventory and nothing ever happens and here they are collecting over 100 parcels, and stating he watches very closely what happens in the City of Gary, week by week, month by month, year by year, and on an annual basis they may divest themselves of a handful of properties or maybe a dozen properties, but they've been acquiring them a cliff, Mr. Nowacki, continued on, referring to a property being donated today, stating it's right smack in the middle of the Hudson & Campbell Fitness Center, which he stated was build nearly 30 years ago, and says, this day they're trying to acquire this piece of property that's right dead in the middle, continuing with public comment, Mr. Nowacki, stated, that the Commissioners are going to have to find some way to twist someone's arm or hold someone's underwater, until we get taxes that are related to "market value" and something else, Mr. Nowacki, continued on, stating, obviously these are not "market value", and ended his comments stating sorry to the Board and Merry Christmas. Commissioner Allen gave response, stating, a few years ago there was an election in Lake County and the election was to determine whether to retain Township Assessors and each municipality had an opportunity to vote whether to retain their Township Assessors, and so the citizens in Calumet Township voted to retain the Township Assessor, so the complaints about the properties in Gary being over assessed or grossly over assessed are problems that may or the implication is that it's caused by the Assessor, also believing that some properties are over assessed, but the citizens elected to retain the Assessor whereas if they had made a different decision in that election, then the County Assessor would have purview over the properties in the City and would be in a

position to make those assessment, not knowing whether or not that would've changed anything, but it may have, the County Assessor may have decided to assess the properties at a lower value than what the Calumet Township Assessor is doing, and agreeing that that's creating a problem in the City of Gary, its causing people to walk away from a lot of their property and just abandon the property and it has created a tremendous problem in the City, and as far the property located with the Hudson&Campbell complex, if Mr. Lebroy(owner) had paid his taxes then the property would not even be before the Commissioners for donation, so when the taxes become delinquent then the Commissioners can make that decision about whether to donate or not.
