Comes now, Attorney John Dull, before the Board of Commissioners, stating, "with regards to the Northwest Indiana Habitat for Humanity, I've reviewed it and it's only one and it's been through the process several times", Repay, asked, "does this action now refer to some other point in our agenda?", Response, "yes, number 11" Repay, continued, "Okay, two certificates to Gary Housing, 11.1 and 11.2" Tippy, asked, "which one is Habitat for Humanity?", Repay, responded, "I would imagine Habitat for Humanity or 11.2 is a list of various non-profit entities", John Dull, spoke, "there is a publication, that she submitted to the Board, that was attached that has the actual key numbers in it and had to be put in the newspaper", Allen, spoke, "I guess he's saying for the purposes of the Agenda, we don't see Habitat for Humanity", Tippy, commented, "I'm confused because we have a Public Hearing for the Pastor and a Public Hearing for the Habitat", Dull, interceded, "what you have is the following, because they're different things, first of all, you have non-profits, you have to have a Public Hearing and they're two of them that made an application, second of all you have Gary Housing Authority which wasn't included in our study with IUN and they've got a request for two, then you have the parcels that are in the IUN report that we're working on from all of the other Cities and Towns, so you have actually three" Repay, interceded, "so the Notice that went out, notified the Public of our intent to donate these Certificates, and then for the purposes they have an opportunity to speak, they don't have to speak, but this is what you're proposing that we make donations and that's the document that Stacie gave us all", Dull, replied, "yes", Repay instructed John to go backward in his presentation for clarity, stating, "so you're asking for us to take action on the donations of these certificates on 11.1 and 11.2", Dull, commented, "I'm asking you for permission to donate only to these non-profits that I just handed you, they're separate", Repay, replied, "ok", Dull, continued, "and as you'll see, the Reverend has eight, and Habitat for Humanity has one", Tippy, spoke, "ok so which Agenda item is this one?", Fech, spoke, "I think, if I could Commissioners (Repay gave permission), I think their should be an 11.3 and an 11.4 added to the Agenda, 11.3 adding Habitat for Humanity and 11.4 adding Pastor Gilliam's request", Tippy, spoke with motion, "I'll make a motion to amend the agenda per Attorney Fech's recommendation", Allen seconded the motion to amend the agenda per Attorney Fech's recommendation, recommending adding an 11.3 and an 11.4 added to the Agenda, 11.3 adding Habitat for Humanity and 11.4 adding Pastor Gilliam's request. Comes now, Attorney Dull, continued with Presentation, under agenda item 11, Action And/Or Reports on County Owned Property, stating, "I want to point out a couple things, first of all Dr. Ellen Szarleta, she worked on this project, but before we get there, I want you to, recognize Jessica Dec, Supervisor of Auditor Tax Sale Department, this employee is outstanding, she saved the validity of my report and Dr. Szarleta's report because we got bad data from SRI and from Don(Onyx Electronics), and what she did was, she went through parcel by parcel of the ones that we're going to recommend to donate to make sure that they were in valid categories, for instance when I met with you, Commissioner Tippy, individually, I told you Cedar Lake had thirty, but four of those were redeemed, that young lady right there, I'm going to send a letter of accommodation to her Boss, she's an outstanding employee and saved us, so these are the parcels that we're dealing with, now I want to point out a couple things, Commissioner Tippy, remember when the County bought those parcels of property over there for a house or drainage and you brought them to me and said these are on the tax sale and make sure you get them off, they're off, Jessica took them off yesterday, so we do not have them on the Sale and you put the petition through to cancel the taxes, the other thing is that Jessica and Dr. Szarleta and the people from Gary identified eleven pieces of property that are in that same category and what we're going to do is to help Gary straighten them out, so these parcels here are not on the Sale, now we get to the area where we're recommending the number of non-first time churners, so there are things that have been through this system many many times and they've been requested by these particular units, don't get upset with the volume for the City of Gary, last year they did about this many, and I met with them, Wendy, and they're geared to go, I would recommend that you make all of those particular donations of the non-first time churners, they total five hundred and thirteen", Allen, asked "is that agenda item 11.2", *Repay*, answered, "that would be 11.2, I believe, yes", *Tippy*, asked "are you separating out the first timers?", *Dull* answered, "yes", *Repay* spoke, "so the number is 513 as opposed to 548, in other words, if I could paraphrase a little bit, they requested 548 but they were not entitled, based on Jessica's work, to the thirty-five because those thirty-five have not been exposed to a Sale yet, so we're taking 548 minus 35 we've got 513, good job", Dull continued, "so I'm recommending that those be.......I want to commend a couple units, Cedar Lake first of all, outstanding, Dyer, outstanding, Hammond and East Chicago and Merrillville did outstanding jobs along with the City of Gary", Repay, commented, "so everybody did outstanding, right", Dull continued, "I know but considering the number and what they did to figure them out, they did outstanding work, so I want to recommend the 513", end discussion.

Allen made a motion to accept Mr. Dull's recommendation based on the analysis and report, Tippy seconded the motion. Motion carried 3-0.

Comes now, John Dull, before the Board of Commissioners, continued presentation, stating, "we have first timers that I'm recommending, that you approve, approve the transfer of the first timers to certain units listed on that sheet, one of the new things that we did, in the project, was to look at the first timers and make a decision whether or not they fit into the masterplan of those units, ok, now I can tell you, Commissioner Repay, I know you're kind of against giving first timers, what I did for the City of Hammond, City of Hammond you'll have, you'll see right here, you'll see that "ttd", I took that out, that's a parcel that's inside one of those transportation districts that they will deal with, so it's not on there anymore, but these other first timers fit in clearly with the masterplan of the units and one of the new things we are trying this time is to get you to approve a first timer", end comment by Dull, Comes now, Commissioner *Tippy*, with question, stating, "so when you say that you've evaluated each one of these in terms of it's proximity to existing governmental facilities and things of that nature?", Dull, responded, "yes we have and it's been quite a task, here's for instance, Hammond East Chicago and Gary, the first one is, you'll see, East Chicago had, look at the bottom, look at what we did, we went thru and you'll see at the bottom there's from one-two-three-four, the first five, the City is the adjacent owner of that property, number six it says buildable lot in an established neighborhood, City will market for residential, those are some of the things that Mike was not against, then seven and eight are half houses and they're going to try to put them together into one, twelve is a commercial parking lot, and so we feel that there's a benefit to doing this now since each one of these went thru and requested, if you look at Hammond you will see that they also have, Kevin Smith put together a request, one of these was that Towle property, I took that out, number one", Repay, stopped Mr. Dull, stating, "my personal opinion, not withstanding whatever is in there masterplan, my personal opinion and my opinion ever since I got here has been, they should be allowed to go on the sale one-time, so I thought that the work here in isolating the 513 was appropriate, so you're telling me now that you want us to potentially put these 35 or 17", Dull spoke, "well for Hammond it's 27, remember I had to change the numbers rather quickly on those things that were submitted, because of the error that Jessica found", Repay, continued, "so 27 that had been exposed and 11 that had not" Dull, replied "correct", Repay continued, "so are you now asking that we", Dull commented, "that should be 38 because I took off the transportation development district", Repay continued, "I don't want to give them the first timers, that's my opinion"

Comes now, Dr. Ellen Szarleta, to speak before the Board of Commissioners, stating, "I just wanted to add, and I think that probably everybody does know, that Communities spend a great deal of time, we work with them on these key parcels and one of the issues they have is that sometimes there are parcels that interrupt an economic plan and so we ask them to very carefully think about which ones, which first timers, would actually make a significant difference in there opportunity to develop if they were to acquire, it's not just we want all first timers, these are ones that they see as being significant baring close to plans that they have in order to move forward", end comment, Tippy asked, "so potentially someone could buy one of these properties on the sale and block development or block the plan within a municipality", Allen asked, "so for these first timers, they've indicated to you that they have specific plans to develop these properties, to his point just giving them to them for the sake of giving them to them, I think that would be his concern, because we have speculators and probably the biggest example would be the Hard Rock everybody starting buying property around the Casino along 80/94 in Gary in the corridor no intention of doing nothing but I bought it for five thousand I'm going to sell it for a hundred because the Casino showed up, that would be a concern", Dr. Szarleta, continued, "right and so since the Communities themselves have their ideas for how they want to have those properties developed and they're set, ok, they have an idea of what they're going to need in order to be able to move forward with the Cities or the Communities development plan and so these are considered to be key to that plan and their justification was provided to us, as John had just shown you, when the response back on the project masterplan request, so I just want to throw that in there as a consideration, I think sometimes the whole process is not understood, I'm not saying that your concern Councilman Repay is not valid, I'm just saying that this is a limited number of parcels that they have identified as being critical", Allen asked, "so would you say going forward, that this should be done on a case by case basis, what I mean by that is, okay you're telling me you want it so what's the plan, and if they say we have no plan then, to Commissioner Repay's point, then we put it back on the Tax Sale", Tippy asked, "does this decision need to be made today", Dull, responded, "today, because we have to get Donnie and the newspaper going", Repay, asked the pleasure of the Board, end discussion.
