Bilski asked County Assessor LaTonya for guidance regarding any guidelines for requirements such as parcel to staff ratio in each assessor's office. LaTonya stated that there are no established guidelines but there is a formula that each office is aware of. LaTonya said that she would get that information back to the council before the second reading in October.

Jorgensen asked Mark Pearman why the assessor's office is having delays in computer software upgrades. Mark stated that the issue is that they have been spending the last year upgrading their communications network. Mark said that all offices are complete with the exception of Hobart. He continued that there has been a battle between AT&T and Frontier in getting the fiber optic line installed correctly. "It's been mis-installed three times over the last six months. This is an AT&T problem. We've had major problems with AT&T since the Coronavirus. Mark said that they had a meeting with AT&T last week and they have promised that the issue will be corrected by the end of this month.

Jorgensen requested that Judge Dimitrijevic speak with Senior Judge Cantrell and Community Corrections regarding the needs of the court.

Jorgensen asked Marty Goldman to make sure that all judges and Scott have a copy of the judicial utilization rates. Marty asked that Jorgensen put the request in writing and send the request to Judge Sedia.

No action was taken by the Council during this meeting.

There being no further business to come before the Council, it was moved and seconded that this Council does now adjourn, to meet again as required by law.
