5. Employment visits may be made at any time of the day or night to ensure my compliance with the Intensive Probation Program.

- 6. Other conditions may be ordered as part of the treatment program which may include, but not limited to the following:
  - a) Individual counseling (juvenile and/or parent/guardian)
  - b) Family counseling (therapy)
  - c) Group therapy
  - d) Education/Vocational training
  - e) Community service
  - f) Restitution
  - g) Urinalysis random test (failure to take will result in a modification)
  - h) BAC (breathalyzer) random test (failure to take will result in modification)
- 7. There will be periodic reassessments done on your case to see about a possible movement from Level Two to Level One or to gain possible privileges.
- 8. I understand that any violation of the program could result in my apprehension and transportation to the Lake County Juvenile Center.

This is a sample of violations that may get you further sanctions or picked up and detained at LCJC but not an all inclusive list:

- a) New criminal charges
- b) Failed drug test
- c) Failed BAC test
- d) Suspension from school
- e) In-school suspension or detention
- f) Leaving the house without permission
- 9. If the juvenile receives an out-of-school suspension, the juvenile must contact the Intensive Probation office that same day. During the time the juvenile is suspended, alternative sanctions may be ordered.
- 10. If the juvenile is ill, absent from school, receives an in-school suspension or a detention, it is the responsibility of the juvenile to contact the Intensive Probation office immediately. (All illnesses and absences must be called in to the Intensive Probation office no later than 8:45 a.m. that same school day).
- 11. We understand that fees may be charged for the equipment required for this Program.
- 12. The policy regarding the equipment that is assigned to me anklet ID # \_\_\_\_\_ which will be worn by me while I am being supervised under the Intensive Probation Program is as follows:
  - a) At the completion or termination of the program, all equipment must be returned in good condition.

- b) The equipment used in the program remains the property of Lake County Juvenile Center/Community Corrections. Tampering, destruction, theft or loss of the equipment will result in me having to pay the cost for the loss or repair of said unit and may result in criminal charges being filed against me.
- c) As parent or guardian of said child, I/we are responsible for loss or damage to the equipment.
- 13. This Program will continue from the time it is ordered by the Court until I am specifically released, in writing, by the Court.
- 14. I understand that any violation of the Program could result in my apprehension and transportation to Lake County Juvenile Center.
