(3) If you wish to vote for a candidate seeking a nonpartisan office or on a public question, you must select the appropriate place on this ballot.

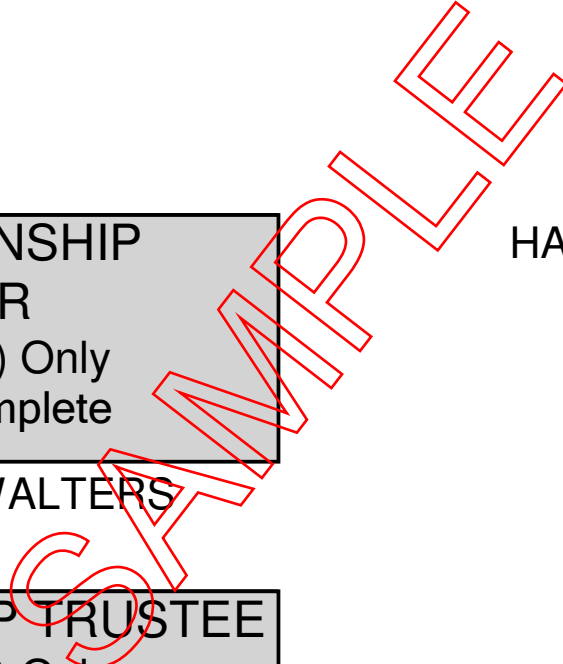
