The Lake County Commissioners are selling a tax sale certificate. The Commissioners will transfer their certificate to the winning bidder. The process is very complicated. People who do not have legal counsel prior to and during the purchase and perfection process may be denied a deed by the Lake Circuit Court because of technicalities. While the Board of Commissioners cannot mandate a potential purchaser to obtain legal counsel because of the complexity of this project, the Board encourages any potential bidder to seriously consider this avenue.
