Board discussion, Scheub began with questions to Assessor Prince, stating that at last months meeting the Board gave approval for \$375,000 maximum, no more and that was in the motion, and you (Prince) stated all through the minutes that there was no additional cost for training no additional cost for anything and now you (Prince) come back this month and you (Prince) want \$120 per hour for additional training and \$200 per hour for additional programming, where under the current contract we're not thru anything there and I cant for the life of me see how you (Prince) expect us to pass this when you (Prince) that you did not need any more money but the \$375k as maximum and now you're coming back and probably asking for another 100k. Prince, responded, starting by saying that as a Council person, he has sat on both sides so he absolutely respect the Commissioners right to question, if its for the benefit of the County but in this instance Commissioner, Prince stated he thinks its absolutely the opposite, and largely an attempt by the Commissioner to continue to express a distain for him (Prince) personally because of past decisions. Scheub, replied to Assessor Prince, that "you're totally wrong"! Scheub, mentioned that he's doing his job. Prince, continued the discussion stating that the accusations made are inaccurate and that Commissioner may not be as aware as he thinks, Prince continued on stating that "we" reached out to everyone, i.e. Townships, Data, opened up to a bid process as requested by Commissioners, etc. even though they knew from experience that this is an absolutely the right move to make so today, assertions have been made that simply are not true, so the first suggestion made is that the Assessor said that there would be no additional cost and that's exactly what was said, said Prince, but the question was as it related to the Agreement and Prince and Scheub referred statements in the discussion from the Minutes of the October 21, 2015 meeting in an attempt to clarify, Prince continued stating to the Board, that what you have here is a Master Agreement and the reason you have two separate Agreements, and "I think this speaks more to your lack of knowledge into the process Commissioners", because this is the identical process that was followed before, what happens when you enter into an Agreement such as this the State only allows certain guidelines in the Contract, that's what you approved last week (he may have meant last month) and there's no additional charges to that, what we have here is something completely separate and it speaks to support and things of that nature, the State simply does not require or allow any other contracts so you have to have a Master Agreement but most importantly, continued Prince, lets talk about the basis of why we're here as it relates to the claims that the County will be charged extra money, again completely inaccurate, what you're reading are provisions where there could cost additional revenues but all of those provisions are hypothetical situations, there's no additional charge for training, there's no additional charge for support and that's as simple as it can be and the last claim for an additional 100k is simply inaccurate. Prince, continued, that analysis were prepared and presented to the Board of the exact cost, and on a 10-year analysis, which is the best way to look at this the only difference in the cost between what we have now and what we're proposing to get is about 10 thousand dollars and that's on a ten year basis one thousand a year average, Prince continued, all of the users agree that this is a far superior product, it's going to create the efficiencies that we need not only in the County Assessor Office but in all of the Assessors and Prince mentioned that for himself this was an administrative decision and to do what is best for the County, this was driven by the users, by his capable Chief Deputy an employee for ten years of the Assessor, all of the Township Assessors and driven by 47 other County Assessors to agreed to implement this software and get rid of consequently the one that we absolutely have, prior to, again the reason we want to change, commented Prince, is because any one in technology and dealing with software knows that as time goes on there's updates that need to be made and as long as this company is willing to adhere to our demands and needs in the Office, we're going to be satisfied with them and we're going to do so in the most efficient and expeditious manner that we can.
